Foreign Currency Time Deposit (FCTD) Standard Settlement Instructions (SSI)



Introduction

The purpose of this guide is to provide detailed instructions for sending payments to U.S. Bank for Foreign Currency Time Deposit (FCTD) currencies. The information listed within should be used as a guide and presented to your sending bank for proper formatting. Payment information in this guide is formatted according to the individual currency in a SWIFT standard Pacs.008 (formerly MT103) message. Payments made to U.S. Bank FCTD accounts are listed in standard Pacs.008 formatting. U.S. Bank clients should ensure they have the most recent version of this guide by utilizing the [U.S. Bank Foreign Exchange customer resource page](#).

Each bank has its own requirements and processes for sending FX payments. Please reach out to the initiating bank for further and/or differing delivery guidance.

Any change to your standing instructions must be communicated to U.S. Bank Foreign Exchange Operations no less than three business days prior to settlement. Failure to do so may result in settlement after value date and a claim for compensation or use of the previously applicable settlement instructions and a claim for compensation.

Individual country currency holidays are subject to change, booked trade value dates may be amended as a result.

Your Foreign Currency Time Deposit with U.S. Bank resides in the USA and does not have a structured account required by the country in which the currency is domiciled, i.e. IBAN, CLABE, etc. Incoming wires to your Foreign Currency Time Deposit may be considered a cross-border international wire transfer. The sender/remitter will need to format the information based on the SWIFT Pacs.008 fields provided below: Intermediary Agent (formerly 56A), Creditor Agent (formerly 57A), Creditor (formerly 59). Note: The sender/remitter's name and address must also be included in the wire instructions.

If the sender/remitter is trying to enter via their financial institution's online platform, it will need to be entered as an international wire transfer. If it does not allow the sender/remitter to add an intermediary agent field, where U.S. Bank clears the currency, the sender/remitter will need to contact his/her banking representative on how to send the wire transfer. It must be clearly communicated that although the wire is being sent to USA, it must stay in currency and NOT be converted.

U.S. Bank's correspondent bank is listed below in Intermediary Agent. If your vendor/sender of the wire chooses not to use our correspondent bank, you may experience a delay in the funds posting to your Foreign Exchange Account, incur extra bank charges from other financial institutions or incur a loss due to conversion (if funds received are converted to US funds by the other bank).
