The Comptroller of the Currency (OCC) acknowledges receipt of your letter regarding U.S. Bank National Association's (bank) plan to close its branch office located at 653 South State Street, Ukiah, CA 95482, with an effective date of September 14, 2018. The bank's decision to close the branch office is a business decision that does not require the approval of the OCC. However, we will consider your comments in connection with our next Community Reinvestment Act (CRA) evaluation of the bank when we will review the effect of the bank's record of opening and closing offices. In addition, we will take the bank's record of performance under the CRA into account when we review applications by the bank to establish or relocate branches or to merge with other banks.

We have forwarded your comment letter to the OCC's Community Affairs Department in Washington, D.C. Community Affairs will advise you if we intend to convene a meeting with community representatives to explore the feasibility of obtaining alternative financial service facilities.



To The Director for District Licensing,

My name is I have been a loyal customer with US Bank for about fifteen years. After getting married, my husband and I opened a joint checking and savings account with US Bank (my bank) as the customer service was better than his bank. We take care of our banking needs at the branch inside the Safeway on South State Street in Ukiah, CA.

We received an impersonal form letter letting us know that the US Bank branch in Ukiah is closing. We were shocked and disappointed! The solution suggested in the letter is to visit the US bank branch in Santa Rosa. That is an hour drive south of Ukiah! We have three children: ages five, two, and two months. I am NOT driving two hours round trip with three young kids to meet my banking needs. And no, we do not believe in direct deposit.

I also don't understand why the letter told us to contact the Ukiah Safeway branch with questions, the Ukiah branch doesn't have answers. The employees at the Ukiah branch are losing their jobs, what answers can they provide? In the future, I suggest including a phone number of someone who HAS answers. I spent time online and calling 1-800 numbers to no avail. I finally got the phone number for signed the letter, but his contact information wasn't included and it should've been.

and I spoke on July 30th. He said the higher ups made the decision to close the branch and the decision had to do with numbers. I understand that numbers matter, but this branch closing will affect us and other loyal customers. This branch is the ONLY branch serving Mendocino county and Lake county. If you have ever visited Northern California, you would know we live in a more rural area. There are not a lot of high income jobs here. However, a Costco just opened in Ukiah on July 19th: more jobs, more people, and more money will be coming. We hope there could be a way to keep the Ukiah branch open.

We are extremely sad that the US Bank branch in Ukiah is closing. I told my concerns, but I would like those who are higher up to hear my concerns as well, and I want an explanation from someone who made the decision to close our Ukiah branch. WHY is this branch closing? Does it have to do with someone hiring a manager named with no banking experience? That wasn't the smartest decision. Maybe it had to do with letting go last year, that was another dumb decision. We were SO excited when she came back a few months ago! Customer service is important, we return to places where we feel important. We want a relationship (not robots). We hope there is a way to keep the Ukiah branch open.

I want to stay with US Bank, as I have a long banking history and I usually experience amazing customer service. My husband and I will talk about out future banking needs. For now, I look forward to a response as to why the decision to close the US Bank branch in Ukiah was made.





To Whom It May Concern,


